Transaction Fees

Transaction and account maintenance fees are payable on all business current accounts, based on account activity. These are calculated on a quarterly basis and, following at least 14 days notification, charged to your account. Charges are usually applied in March, June, September and December.

Business Account Charge Type definitions

Manual Transactions	Transaction that is not automated or electronic requiring paper to be processed - typically, branch debits, branch credits, credit transfers, cheques drawn on your account, cash debits
Automated Transactions	A payment through an automated central infrastructure, most commonly BACS, e.g., Direct Debits, Automatic Credits, ATM Withdrawals
Standing Orders	A payment set up on your account to pay another account on a pre-arranged date and frequency
Remittance Items	Cheques / postal orders drawn on another account, lodged to your account
Notes Lodged / Withdrawn	Cash lodged to your account or withdrawn from your account
Notes Exchanged	Exchanging one denomination of bank notes for another
Coin Handling	The provision of coin or accepting coin
Quarterly Maintenance Charge	This will be charged to your account every 3 months
BACS Transactions via Business On Line	One automated entry to your account of the total of batched BACS payments using Business On Line and lodged to other accounts (e.g. Wages / salaries / creditor payments).

Unauthorised Borrowing Charges

You should always discuss your borrowing requirements in advance. Unauthorised Borrowing Charges can be avoided by ensuring that there is sufficient money in your account or a sufficient overdraft facility to cover all your outgoings, e.g. Direct Debits, Standing Orders and Cheques etc. Where there is not enough money in your account or overdraft facility to cover all items that are presented for payment, the following charges apply:

	Charged when:	Price
Referral Item Fees	<u>These items are paid.</u> The charge is levied on each of these items up to a maximum of 3 per day.	£19.00 per item
Unpaid Items (out)	<u>These items are returned unpaid "bounced".</u> The charge is levied on each of these unpaid items.	£38.00 per item

You will also pay a higher rate of interest on the unarranged overdrawn amount. For details refer to your Relationship Manager or a Guide to Banking for Business Customers and Rates & Products Guide.

Service Charges

For additional services provided, a charge may be made. These apply irrespective of the type of account or whether the account is operated in credit or debit. These charges are in addition to transaction fees and are usually debited at the time the service is provided.

Cheque Encashment facility abroad..... £20.00

Euro Payments

If a payment request meets the following criteria no charges will apply:

- The payment is in Euros and is less than €50,000 in value
- You provide the IBAN of the beneficiary
- You provide the BIC of their bankers
- You provide the beneficiary's name and address
- You do not specify the value date
- When completing the instruction you must leave the charges blank as we must send criteria payments without a special charge instruction

Bank of Ireland standard charges will apply if:

- The payment amount is greater than €50,000 or is in a currency other than Euros
- You request the payment to be made same day or next day
- You do not supply the beneficiary's IBAN or BIC or if you supply an incorrect IBAN / BIC
